



Before You Sign the Waiver...

*The Grand River and its banks are a nature reserve,
protected by the Grand River Conservation Authority.*

*Canoeing the Grand and other land owners on the Grand River
are stewards of this fragile habitat to thousands of birds, fish and other wildlife.*

To help to protect this natural environment and your safety, please observe the following:



Boaters who engage in profanity, or other loud, aggressive behavior disturb the habitat, other family paddlers, and our neighbors on the Grand. Such behavior will not be tolerated and will result in a ban from future services.

Please dispose of all garbage in receptacles, **NOT** in your canoe or the river valley.

Drinking and boating is illegal in Ontario, and UNSAFE

All coolers may be subject to inspection.

If boaters refuse inspection, or alcohol is found, service will be denied.

If any person wishing to enter a canoe appears intoxicated or unruly, service will be denied.

Credit card info or cash deposit may be required from each payer as security deposit.

No charge will be made to the credit card and/or cash deposit will be returned in full unless late fees apply, or equipment/canoes are left damaged or with refuse in them upon return to CTG at the end of your trip.

We Close at 6PM Daily. Arrival after that time will incur late fees of \$30 per 1/2 hour or part thereof.

Waiver - MUST BE READ IN FULL BEFORE SIGNING:

RELEASE

I acknowledge that canoeing/kayaking and all associated services including shuttle services, are filled with risks which are beyond the control of Canoeing the Grand, a Division of On The Grand Inc. (hereafter referred to as CTG). In consideration of CTG shuttling me and my party by vehicle to the trip destination, and renting canoe and kayak equipment to me and my party, I hereby release and forever discharge CTG, its respective servants, agents or employees from any claim, demands, damages, actions or causes of actions of every nature or kind whatsoever, however caused, arising out of, or in anyway connected to the renting of canoe or kayak equipment. I declare that this release is binding upon me, my heirs, executors, administrators and assigns.

I agree that no alcohol or illicit drugs will be consumed by me or my party while on this boating trip.

Damage to equipment

I agree that I am fully responsible for all rented equipment and that I will remunerate CTG for any/all losses or damages incurred by me or my party.
